## WARNING

**Under Florida law, an equine activity sponsor or equine professional is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities. "Engages in an equine activity" means riding, training, assisting in veterinary treatment of, driving, or being a passenger upon an equine, whether mounted or unmounted, visiting or touring or utilizing an equine facility as part of an organized event or activity, or any person assisting a participant or show management. The term "engages in an equine activity" does not include being a spectator at an equine activity, except in cases where a spectator places himself or herself in an unauthorized area.**

In consideration of the acceptance of my participation and/or the participation of my child or ward, in the horseback riding activities, lessons, horse shows, and/or stable management classes offered by Conquest Farms and with the understanding that a horse may be startled by sudden movement, noise or other factors, and may shy suddenly, rear, stop short, bite, buck, kick or run with its rider, by my signature hereon, I hereby assume all risks associated with horseback riding and associated activities including, but not limited to, those risks set out above, and hereby waive any and all claims, actions and causes of action that may now or hereafter have against, and release and will indemnify and hold harmless from the same Conquest Farms, and its officers, directors, stockholders, affiliates, employees and agents, for all injuries and damages that I or my minor child or ward may suffer or sustain in connection with or arising from my participation or my minor child's or ward's participation in the horseback riding and associated activities offered at Conquest Farms, even if due to any negligence on the part of any of them.

This Participation and Waiver Agreement shall be binding upon me and my heirs, personal representatives, and assigns, as well as those of my child or ward (if for a minor). I understand that this Participation and Waiver Agreement will be kept on file and shall apply to each time I rent and use one or more horses and equipment to participate in horseback riding activities, lessons and/or stable management classes. If any information given below changes, I will give Conquest Farms enough notice of such change. I agree that Conquest Farms shall not be obligated to inquire if there have been changes each time I or my child, participates in horseback riding activities, lessons and/or stable management classes. I understand that by signing this form, I am bound by the liability laws of the state of Florida, and any rules or policies held by Conquest Farms in their entirety.
